Somalia: US forces kill Al-Shabaab Leader

The US has said its military forces have carried out an operation against al-Qaeda-linked al-Shabab fighters in Somalia. "We are assessing the results of the operation and will provide additional information as and when appropriate," said spokesman John Kirby on Monday. A senior Somali intelligence official said a US drone targeted al-Shabab leader Ahmed Abdi Godane as he left a meeting of the group's top leaders, according to the AP news agency. Godane, also known as Mukhtar Abu Zubeyr, is the group's spiritual leader under whose direction the Somali fighters forged an alliance with al-Qaeda. The Somali official, speaking to the AP on condition of anonymity, said intelligence indicated Godane "might have been killed along with other militants". The official said the attack took place in a forest near Sablale district, 170 kilometers south of the capital, Mogadishu, where al-Shabab trains its fighters.

The US military assistance comes as Somalia's army and African Union (AU) troops are continuing a major offensive against the armed fighters. In the north of the country, security forces say they have captured districts in the Hiran region, without a single shot being fired, according to Al Jazeera's Mohammed Adow, reporting from Fidow, on the border of middle Shabelle and Hiran regions. Government forces are also seeking to capture the seaside port of Barawe - al-Shabab's official headquarters - south of Mogadishu. On Monday al-Shabab fighters carried out a car bomb and gun attack against an intelligence headquarters in central Mogadishu, leaving at least seven fighters and five others dead. Al-Shabab fighters have targeted key areas of the Somali government or the security forces in an apparent bid to discredit claims by the authorities - who are backed by the African Union's 22,000-strong AMISOM force - that they are winning the war against the armed group. The armed group is fighting to topple Somalia's internationally-backed government, and regularly launch attacks against state targets, as well as in neighbouring countries that contribute to the AU force.

Shocking results Inspection Danish Authority on Dahabshiil

The FSA, the Danish Supervisory Authority, conducted a review on Dahabshiil in Denmark. They inspected Dahabshiil in order to investigate whether the company complies with applicable rules on money laundering cases.

Based on the inspection, the FSA believes that Dahab Shiils measures to limit the risk of money laundering and terrorist financing are insufficient, and that the company has violated the essential elements of the Money Laundering Act. This assessment is paid special attention to the company's high risk of being misused for money laundering or terrorist financing. The FSA has therefore decided to report it to the police.

FSA investigation has also given rise to a number of orders on the basis of:

Deficient internal procedures and training.

Lack of identification of customers.

Inadequate compliance awareness, monitoring, investigation and reporting.

Performing any agency.

FSA believes that the company's internal training materials are very general and is clearly suffering from the original from DahabShiil International, since teaching is not adapted to the Danish rules. The FSA has ordered the company to ensure that its employees and money laundering responsible are aware of the obligations contained in the Money Laundering Act, and to provide adequate written internal rules.

The FSA has assessed the company's procedures for identification of customers and has selected a number of customers to sample analysis. Against this background, the FSA ordered the company to ensure that respectively its regular customers and occasional customers are legitimized adequately, and to implement procedures that ensure that the company obtains sufficient information about customers' purpose of the business relationship and the intended scope. In addition, the Company is required to ensure that the identity and control information stored for at least 5 years after the business relationship has ended.

The Company has no specific examples of the employees have been aware of a suspicious transaction. The company does not even have a monitoring system, but informs that its operations are supervised by DahabShill International in Somalia. The company has not had cases where they have investigated a suspicious transaction details, and thus has not made notification to the Public Prosecutor for Serious Economic and International Crime (SØIK), which the company grounds that monitoring is carried out by DahabShill International.

Note Compliance Department Kaah Express: As you can see it is very important for Kaah Express to comply with the AML/CFT regulations, as the risks are high for Somalian Remittance companies!
